**Resolution 2014-10**

**Authorizing Disposal of Surplus Property**

---

WHEREAS, the Fire District is the owner of certain surplus property which is no longer needed for public use; and

WHEREAS, the Commissioners are desirous of selling said surplus property in an “as is” condition without express or implied warranties.

NOW THEREFORE, be it RESOLVED, by the Commissioners of Fire District No. 1 in the Township of Deptford, County of Gloucester, at a duly-authorized and noticed public meeting of the Commissioners held on February 5, 2014, as follows:

(1) The sale of the surplus property shall be conducted through GovDeals pursuant to State Contract A-70967/T2581 in accordance with the terms and conditions of the State Contract. The terms and conditions of the agreement entered into with GovDeals are available online at govdeals.com and also available from the Commissioners of Fire District No. 1, upon request.

(2) The sale will be conducted online and the address of the auction site is govdeals.com.

(3) The sale is being conducted pursuant to Local Finance Notice 2008-9.

(4) The surplus property is divided into “Lots” and a list of the surplus property to be sold within each Lot is attached hereto as Exhibit 1.

(5) The surplus property as identified shall be sold in an “as-is” condition without express or implied warranties with the successful bidder required to execute a Hold Harmless and Indemnification Agreement concerning use of said surplus property.

(6) The Fire District has provided notice of this online sale pursuant to the “Notice of Sale of Property” attached hereto as Exhibit 2.

(7) The Fire District reserves the right to accept or reject any bid submitted.

(8) The Fire District reserves the right to restrict the sale of any equipment that is for emergency response use only to fire, police or other emergency response departments.
